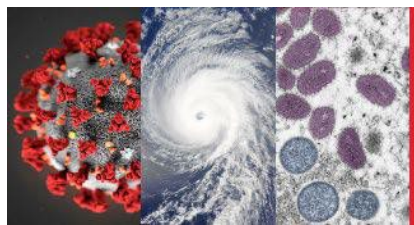

## **Emergency Response Activities**

### **CDC Reports Fourth Human Case of H5 Bird Flu Tied to Dairy Cow Outbreak**

Another human case of [highly pathogenic avian influenza](#) (HPAI) A(H5) ("H5 bird flu") virus infection in the United States has been identified in Colorado. This is the fourth case associated with an ongoing multistate outbreak of A(H5N1) in dairy cows and the first in Colorado. Previous cases were reported in [Texas](#) (1) and [Michigan](#) (2). As with previous cases, the person is a worker on a dairy farm where cows tested positive for A(H5N1) virus. The person reported eye symptoms only, received oseltamivir treatment, and has recovered. CDC has been watching [influenza surveillance systems](#) closely, particularly in affected states, and there has been no sign of unusual influenza activity in people, including in syndromic surveillance.

Based on the information available at this time, this infection does not change CDC's current H5N1 bird flu human health risk assessment for the U.S. general public, which the agency considers to be low. However, this development underscores the importance of [recommended precautions](#) in people with exposure to infected animals. People with close or prolonged, unprotected exposures to infected birds or other animals, including livestock, or to environments contaminated by infected birds or other animals are at greater risk of infection.

### **July 16 COCA Call Provides H5N1 Update for Clinicians and Health Centers**

CDC will host a Clinician Outreach and Communication Activity (COCA) call July 16 to provide an update on the current H5N1 outbreak in the United States and current CDC surveillance and monitoring efforts. Presenters will also provide information for clinicians on testing, using antiviral drugs, and infection prevention and control recommendations.

### **CDC Continues Investigation of Severe Illness Potentially Associated with Diamond Shruumz™ Brand Products**

CDC, the U.S. Food and Drug Administration (FDA), America's Poison Centers, and state and local partners are investigating reports of severe acute illnesses potentially associated with consuming Diamond Shruumz™ brand chocolate bars, cones, and gummies marketed as containing a proprietary blend of mushrooms. CDC provides a [weekly update](#) on the current investigation of cases or adverse effects reported after consuming any Diamond Shruumz™ brand products. As of July 8, 58 total illnesses, including 30 hospitalizations, have been reported in 27 U.S. states. There is one potentially associated death under investigation.
